ANSC*6740 - Special Topics in Applied Animal Welfare Science

Calendar Description

A lecture/seminar course covering in depth topics in applied animal welfare science. The course will review the scientific research into the welfare of a specific animal species or a specific animal welfare problem common across species, focusing on the main threats to welfare, relevant indicators of welfare, and possible solutions to improve welfare.

Department(s): Department of Animal Biosciences

Course Description

This graduate course offers an introduction to poultry welfare. It reviews the scientific literature on the welfare of domestic birds. Real farm visits and hands-on experience will be used to compare and assess bird welfare, teaching students about relevant indicators of poultry welfare and possible solutions to improve domestic bird welfare.

Lecture Schedule

This course will be delivered intensively over 5 days within a 2-week period. The instructor will use class emails and the Class CourseLink site to post detailed information about course events, requirements, and grades. Dates will be coordinated with students, farmers, and industry representatives based on their availability and any farm restrictions (e.g., avian influenza). This may require extending the 5-day intensive period beyond 2 weeks.

During this period, contact time will include lectures, discussions, and welfare assessments. Following lectures, students will be provided with 1-2 hours to read a paper, after which they will break off into small discussion groups. Alternatively, following the lecture, students will be presented with a video or field trip presenting a welfare issue and break out into small groups to evaluate the problem and propose solutions.

At the end of this intensive class period, students will write a short report on a specific animal welfare issue and its solution. This review will be due and presented to the class at the end of the semester (the time and schedule will be determined based on the availability of the students, farmers, and industry representatives).
